

# **ACHS WITHIN SEPA**

There are 3 types of participants in the ACHs of the NEXI Group:

- 1. Primary direct participants;
- 2. Secondary direct participants (\*);
- 3. Indirect participants.

The fee structure for SEPA transactions (Credit Transfers, Direct Debits, Instant payment) includes both a fixed sum, relating to essential and mandatory components of the cost of the service, and a variable fee depending on the actual cost of incoming and outgoing transactions.

The fee structure complies with the principles of transparency and optimization guiding the administrative activity.

Fees are broken down into payments sent and received since the ACHs is an open system capable of communicating with other European ACHs. Therefore, a payment originating from a system may be settled through another one. This ensures that the system is fair.

Fees are applied per banking group.

Such fees are based on the duration of the contract signed with the banks participating in the ACH of NEXI Group.

## The duration of the contract is one year.

The fees for participating in the system are broken down into two charges, plus a one-off sum to be paid when joining the ACHs or when withdrawing from one of the services.

- Entry fee (one-off when joining);
- Annual fixed fees;
- Transaction fees.

#### **ENTRY FEES**

The entry fee is a one-off sum paid when the service is initiated.

Annual fees are charged to direct participant banks at the beginning of each year. No annual fee is charged to indirect participants.

## **TRANSACTION FEES**

Transaction fees are linked to the volume of payments sent and received by PSPs and are based on the quarterly average number of transactions carried out on a daily basis. Messages sent to and received by the ACHs are subject to a fee. Payments are invoiced quarterly.
